PUBLIC NOTICE:

Masks Required Inside County Facilities

WOODBINE, Ga. – August 3, 2021 – Beginning Wednesday, August 4, 2021, face masks will again be required inside Camden County facilities. Following guidance from the Centers for Disease Control and Prevention (CDC), masks are recommended indoors in areas of high transmission, like Camden County, to maximize protection from the Delta variant and to prevent possibly spreading it to others.
