Fantastic news! The Board of County Commissioners has unanimously approved the new annual budget for Fiscal Year 2023, which includes the recommended salary increases for full-time employees contained in the recently completed Compensation and Classification Survey.

My office will be in contact with the Constitutional Officers, Directors and Department Heads over the next few days to discuss preparing the status change forms that will be required to implement the pay changes. The first complete pay period in the new fiscal year begins on Monday, July 11th, so that will be the date that the new pay rates become effective for each of you. You will first see new rates in your paychecks dated July 28th (this is the paycheck for pay period 7/11/2022 – 7/24/2022). Your Directors/Department Heads will be meeting with you individually to go over your new rate of pay, and to complete your status change form.

Thank you all for your patience while this survey was conducted. This is a well-deserved reward for your continued service to the citizens of Camden County.
