ACCESSORY STRUCTURE BUILDING PERMIT APPLICATION INSTRUCTIONS

This building permit is for any *accessory structure, barn, shed, etc.*, as well as some information to assist you in submitting your application.

Our office hours are Monday through Friday, 8:00 AM to 5:00 PM.

The following items must be submitted with your permit application:

- Two sets of structure plans.
- A site plan.
- Septic tank permit. Contact Environmental Health Department, 912-729-6012.
- Land Disturbance permit may be required. Contact Cassie Turpin, 912-510-5706 for a determination.
- A Right of Way Encroachment permit will be required for any permits other than an electric permit. The contact number is 912-576-3028.
- Continuous Footers are required on all additions.
- For *pre-constructed buildings*, include a *Georgia stamped Engineering plan* that meets the *2018 International Building Code* and *120 mph 3 second wind gust* with the application along with a *copy of the invoice*.

There are fees associated with this permit.
