Emergency Operations Center dedicated in memory of Robert D. Mumford, Jr.

Woodbine, Ga. (June 10, 2010) – Over 50 members of the community took part in a ceremony on Saturday, June 5, 2010 dedicating the Emergency Operation Center in Kingsland in memory of Robert D. Mumford, Jr., recognizing his immense dedication and many contributions to Camden County and the surrounding community.

The ceremony began with an invocation by Reverend Randy Mosley of St. Mary United Methodist Church, a presentation of colors by the Southeast Georgia Honor Guard, as well as the pledge of allegiance. Chair David Rainer read the resolution and presented it to Ms. Hilda Mumford. *"I had the pleasure of working with Mr. Mumford throughout the years. Camden County was fortunate to have such a loyal and dedicated public servant like him that cared so much about the citizens. This recognition is very deserving!"* stated Mr. Rainer.

A table was arranged in the front lobby of the EOC which displayed a picture of Mr. Mumford, the building dedication resolution passed by the Board of County Commissioners on June 1, 2010, as well as hundreds of certificates and newspaper clippings recognizing his service to our community. *"We are very proud to have our Emergency Operations Center named in Mr. Robert Mumford's honor. 
