Help Camden County Firefighters Fight Muscular Dystrophy

Woodbine, GA – (July 13, 2011): Camden County Fire Rescue (CCFR) has launched the 2011 “Fill the Boot” drive for the Muscular Dystrophy Association (MDA). Funds raised by the firefighters give MDA the means to continue providing direct services, research and professional and public health education to children and adults with neuromuscular diseases in Northeast Florida and Southeast Georgia.



During Labor Day weekend, firefighters will be out collecting donations from passersby at Wal-Mart on September 2nd – 3rd and Woodbine Grocery on September 3rd – 5th to achieve their goal of \$5,000. Beginning now, County employees are selling mobiles for \$1 and \$5 that will be displayed in County buildings. Additionally, Camden County Government’s HOPE Team [charity committee] will host a bake sale on Friday, August 26th at the Government Services Complex in Woodbine to raise funds for MDA.

Lt. Chris Goebel, Camden County’s Fire Marshal, said, “*CCFR has participated in this event for several years now.
